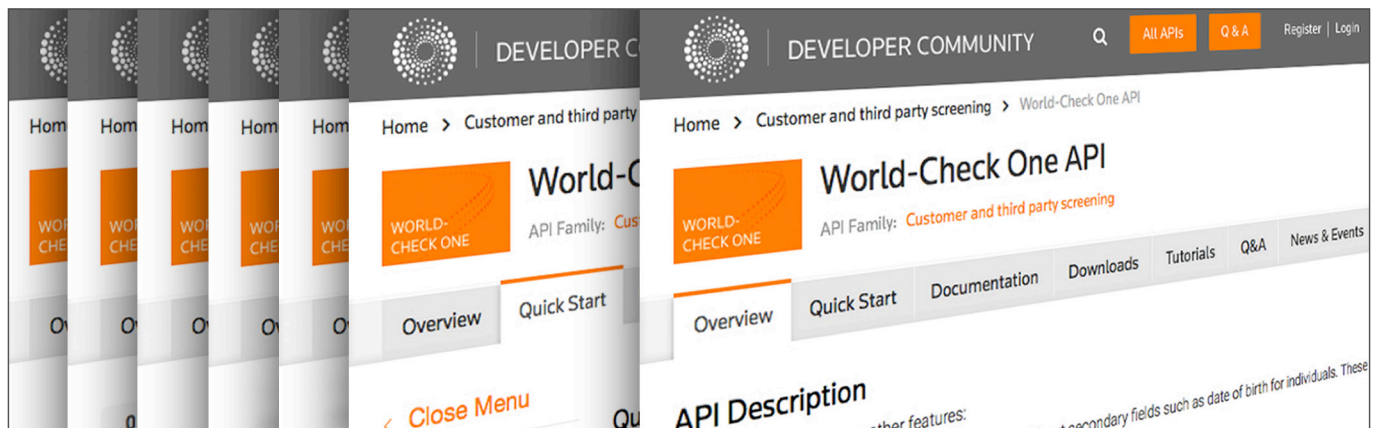
Key features

- Allows the saving or screening of a single name, including any secondary identifiers (e.g. DOB)

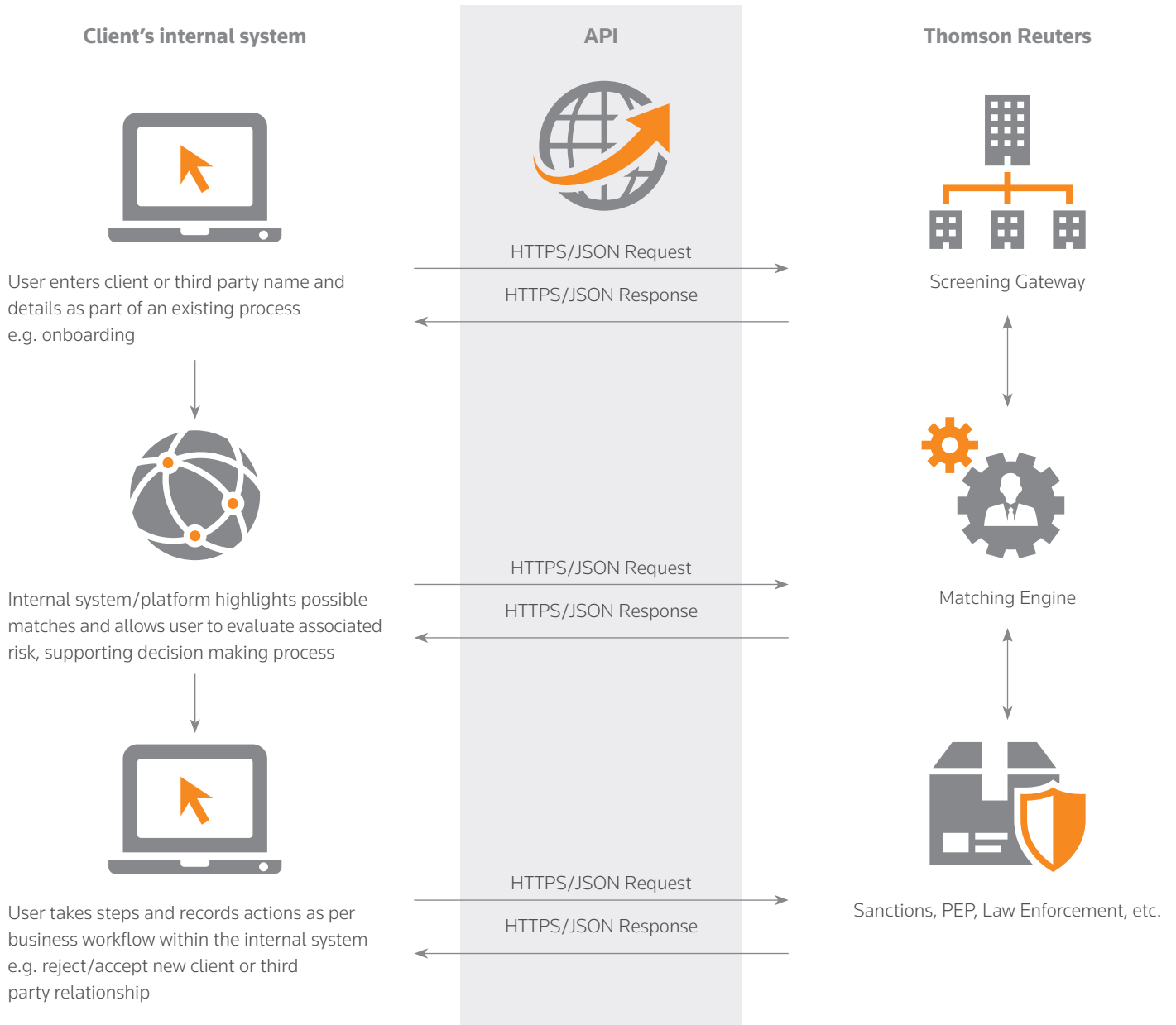
- Allows editing and re-screening of an existing case
